Austin Tennis Academy – 456-6010

[Located off of Hwy 71 0.2 miles west of RM 620](#). When you see McCoy's on your right get in the left hand lane and turn into Spanish Oaks. Go to the guard shack and you are there.

Austin Country Club – [4408 Long Champ Dr.](#) – 328-0031

360 to Westlake Dr. EAST on Westlake Dr. at light. First LEFT onto Long Champ Dr. Follow into Country Club. Tennis courts are on left.

Balcones Country Club – [11210 Spicewood Club Dr.](#) – 258-6672

183 to Anderson Mill Rd. WEST on Anderson Mill Rd. LEFT on Olson. LEFT on Spicewood Pkwy (dead end). RIGHT on Spicewood Club Dr. Club and courts on the right.

Barton Creek Country Club – [8212 Barton Club Dr.](#) – 329-4008

360 to Bee Caves Rd. (2244). WEST on Bee Caves. LEFT on Barton Creek Blvd. LEFT on Barton Club Dr. Entrance to tennis area is on the left past the main clubhouse. Tennis courts are to the right of the golf cart area.

Berry Creek Country Club – [449 Champions Dr.](#) – 930-3783

I-35N to Exit 266. Turn LEFT (West) and go back over I-35. LEFT on Berry Creek Dr. Go 1.5 miles, turn LEFT on Champions Dr. Turn RIGHT at dead end. Club is on the Left one mile up.

Buttercup Creek – [Nelson Ranch Rd.](#) – 258-0655

183 N to Cypress Creek. WEST on Cypress Creek. RIGHT on Nelson Ranch Rd. (about 2 miles). Courts on the right.

Caswell Tennis Center – [2312 Shoal Creek](#) – 478-6268

Lamar Blvd. to 24th St. EAST on 24th. RIGHT on Shoal Creek to courts.

Circle C Tennis – [7401 Hwy 45](#) – 301-8685

MOPAC South past Slaughter to Hwy 45 (a.k.a. Southern extension of MOPAC). LEFT on Kendrick to courts.

Courtyard Tennis Club – [5608 Courtyard Dr.](#) – 345-4700

360 to Courtyard Dr. (just South of 2222). EAST on Courtyard Dr. Take first LEFT after you see tennis courts.

Georgetown Tennis Center – [400 Serenada Dr.](#) – 931-2444

I-35N to Exit 261A (Lake Georgetown/Andice). Turn LEFT (West) at light onto Williams Dr. RIGHT onto Serenada Dr. (2 miles). Club on the right.

Great Hills Tennis – [5914 Lost Horizon](#) – 345-4413

183 to Great Hills Tr. WEST on Great Hills. RIGHT on Rain Creek Pkwy. LEFT on Lost Horizon to courts.

Hill Country (Westwood HS) – [12400 Mellow Meadow Dr.](#)

183N to Lake Creek Pkwy. WEST on Lake Creek Pkwy. LEFT on Mellow Meadow Dr. (first stop sign) to Westwood HS

Lakecliff Racquet Club – [Google Map](#) 830-798-1900

From the intersection of 71 and 620 go West on 71 for 13 miles. RIGHT on Paleface Ranch Rd. and go North for 3.6 miles. RIGHT on Haynie Flat Rd. (3 way stop sign). Go 3 miles East on Haynie Flat and turn LEFT at second guard gate. Pass through the guard gate and take first RIGHT. Racquet club is on your left at the end of the street.

Lakeway World of Tennis – [1 World of Tennis Square](#) – 261-7222

620 to Lakeway Blvd. WEST on Lakeway Blvd. Follow signs to World of Tennis. LEFT on The Hills Dr. RIGHT on Trophy Dr. Courts straight ahead.

Lost Creek Country Club – [2612 Lost Creek Blvd.](#) – 892-0173

360 to Lost Creek Blvd. WEST on Lost Creek Blvd. Entrance to club is 1.9 miles on the RIGHT. Follow entrance road to courts.

Onion Creek Country Club – [2150 Onion Creek Pkwy.](#) – 282-2829

I35S to Onion Creek Pkwy (South of Slaughter). LEFT on Onion Creek Pkwy (over I35). RIGHT on Pinehurst (stop sign). Turn LEFT at tennis court sign on the left (about 300 yards). Courts on the right.

Pharr Tennis Center – [4201 Brookview](#) – 477-7773

I35 to Airport Blvd. EAST on Airport. RIGHT on Wilshire. Immediate LEFT on Brookshire. Courts on the left.

Quail Creek Country Club – [2701 Airport Hwy 21](#) – 353-1664

I35S to Exit 205 (Luling/Hwy. 80). LEFT under I35. LEFT on Airport Hwy 21 (Past the Wal-Mart). Club on the left past the RR tracks.

River Place Country Club – [4207 River Place Blvd.](#) – 338-0665

360 to RR 2222. WEST on 2222. Go about 4 miles to 3rd traffic light. Turn LEFT into River Place. Clubhouse is 2 miles up on left.

Shady Hollow ([Bowie HS](#)) – 280-6309 or 289-0621 (cell)

MOPAC South to Slaughter Lane. LEFT (East) on Slaughter to Bowie HS. Courts are on the west side of the HS. Matches may also be played at [Akins HS](#). Akins is located on FM 1626 and S. 1st St. near I35.

South Austin Tennis Center – [1000 Cumberland Rd.](#) – 442-1466

Lamar to Oltorf. EAST on Oltorf. RIGHT at first light. RIGHT on Cumberland to the courts.

St. Stephen's – [2900 Bunny Run Rd.](#)

360 to Westlake Dr. (South of 2222 and past Courtyard Dr.) WEST on Westlake (follow signs to St. Stephen's). LEFT on Bunny Run (dead end). Enter Campus and turn right (follow signs to athletic facilities/tennis courts). Park and walk up to the courts.

Steiner Ranch -

2222 to 620 (left on 620). 2 miles to Quinlan Park Blvd (2nd turn into Steiner Ranch). Turn left. 2 miles to Towne Square Community Center - turn right. If the road narrows to 2 lanes, you've gone a bit too far.

MOPAC to Southwest Pkwy. WEST. RIGHT on Republic of Texas. Go 3 miles then RIGHT on Travis Country Circle. Go 3 miles then RIGHT into Park Entrance.

MOPAC to Steck. WEST on Steck. RIGHT (North) on Mesa. LEFT on Hyridge. RIGHT on Westover Club Dr. to courts.

MOPAC to 35th St. Exit. WEST on 35th St. Follow road past flashing light. Bear Left to stay on 35th St. Club is at the end of the road on the right.
